#### Renewal of HVAC Maintenance Contract

Motion and second by Mr. Michael and Ms. Reahm to approve a resolution to renew the contract for HVAC Maintenance to Peterson Service Company for the period July 1, 2017 – June 30, 2018. The contract is for quarterly HVAC maintenance services at the Mullica Hill, Greenwich and Logan branches of the Gloucester County Library System in the amount of \$11,383 and to provide necessary repairs on a time and materials basis at the rates specified in the original bid proposal.
