#### Change to Salary Structure

Library staff will receive a 2% raise in 2016 based on their ending rate in 2015. Staff who received a longevity payment in 2015 will have the amount of the longevity payment added to their base salary to determine their 2016 rate. There will be no midyear raise or step increase. There will be no longevity payments.
